Evaluation of Experimental A Insecticide in Dark Tobacco 2008 – UKREC, Princeton, KY

- Objectives of trial:
 - Evaluate tolerance of dark and burley tobacco to foliar applications of Experimental A insecticide at various rates

 Evaluate control of *Lepidoptera* worm pests (budworm, hornworm) of tobacco by Experimental A insecticide.

Evaluation of Experimental A Insecticide in Dark Tobacco

2008 - UKREC, Princeton, KY

- Dark tobacco trial: Univ. of KY Res & Educ. Ctr, Princeton, KY
- Dark variety: PD 7302LC
- Transplanted June 2, 2008
 - 40" rows, 32" plant spacing (4900 plants/acre)
- 4 treatment applications made: 6/30, 7/14, 8/1, 8/26
- First application made at egg lay, later applications made just prior to threshold
- Hollow cone 10X nozzles directed toward rows, 15 gal/A
- Plot evaluations made following each application
 - 7 plot evaluations, hornworm predominant insect pest in dark trial
 - Crop phyto injury, worm damaged plants, actual worm counts
- RCBD with 4 replications
 - 2-row plots, 40-ft. long
- Fire-cured tobacco: yield and quality data collected


